

-QUITCLAIM DEED-

Melvin L. Stewart and Mary Lou Stewart, Grantor, releases and quitclaims to, Harold A. Campbell, Grantee, all right, title and interest in and to the following described real property:

That portion, if any, of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 36, T38S, R9EWM, Klamath County, Oregon lying East of the following described line:

Beginning at the long accepted C-W 1/16 corner of said Section 36, from which the West $\frac{1}{4}$ corner of said Section 36 bears S89°58'32"W 1302.15 feet; Thence North 2640 feet, more or less, to a point on the North line of said Section 36 with bearings based on Tract 1152--North Hills.

Excepting that portion deeded to the City of Klamath Falls by Deed Volume M85, page 20984 and El Paso Natural Gas Co. by Deed Volume 383, page 145.

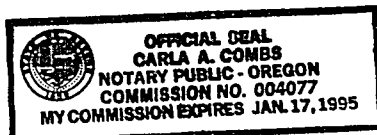
