hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated August 25, 1983, between STATE OF OREGON, represented & acting by the Director of Veterans Affairs as seller and PAUL M.
