oil, gas and other mineral and hydrocarbon substances beneath the surface
thereof. Said conveyance shall be made subject to all conditions, cove-
nants, restrictions, reservations, easements, rights and rights of way
of record or appearing in the recorded map of said tract and specific-
ally the covenants, conditions and restrictions set forth in that certain
Declaration of Restrictions recorded in the Official Records of Klamath
County, all of which are incorporated herein by reference with the same
effect as though said Declaration were fully set forth herein.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor

and demands of all persons whomsoever, except those claiming under the above described encumbrances.
