Shepperd & Patsy A. Shepperd, husband & wife, with survivorship hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendor's right, title and interest in and to that certain contract for the sale of real estate dated August 31, 1985, between Mark A. Shepperd & Carol L. Shepperd, husband & wife as seller and Chris Wieland
