B. Grantee is the owner of a parcel of real property situated in Klamath County, Oregon, described as:

EXCEPTING THEREFROM that portion conveyed to the United States of America recorded in Volume 99, page 481, Deed Records of Klamath County Oregon. ALSO EXCEPTING THEREFROM that portion conveyed to Klamath

County by deed recorded July 6, 1977 in Volume M77, page 11849, Microfilm Records of Klamath County, Oregon.

C. The parties agree as follows:

AGREEMENT:

SECTION 1. GRANT OF EASEMENT.

1.1 Grantor grants to Grantee an easement over and

across the Grantor's Property described as follows:

A strip of land 16 feet in width lying parallel and eight feet east of the west line of Lot 28 in Block 15, Tract 1064, First Addition to Gatewood, hereinafter called "The Easement".

which Easement shall be used for a water line for the use and benefit of the Grantee's Property, and shall run with the land and be continuous. Grantor further grants to the Grantee the right of the Grantee to convey the easement to the City of Klamath Falls for use in it's water system.

Grantor grants to Grantee the right to enter upon the Easement for purposes of repair, installation or reinstallation of water lines. Grantee will repair any damage to the landscaping, driveway and fencing caused by the repair, installation or reinstallation.

SECTION 2. CONSIDERATION

In consideration of the grant of this Easement, Grantee has paid the Grantor the sum of \$1,500.00.

SECTION 3. BREACH OF OBLIGATIONS

In the event of any litigation arising under this Agreement, the other party shall be entitled to require such performance by suit for specific performance or, where appropriate, through injunctive relief.
