Beginning at a point on the South line of the NE1/4 of Section 32, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, from which the quarter corner common to Sections 32 and 33 bears North 89 degreed 34' East 1002 feet distant; thence North 0 degrees 06' East 1008.65 feet to the Southerly line of the Klamath Falls-Ashland State Highway No. 66; thence South 72 degrees 21' West 340.1 feet; thence South of degrees 06' West 907.8 feet; thence North 89 degrees 34' East 324 feet to the point of beginning.
