

CONSENT AND SUBORDINATION AGREEMENT

WHEREAS, Crown Pacific, Ltd., successor to Shevlin-Hixon Company hereinafter called the "CREDITOR", has an interest in or lien upon the real property hereinafter described by virtue of a road easement dated the 12 day of August, 1943, and recorded the 25 day of October, 1943, in Book 159, Page 300, and Modification of Agreement dated 14 day of February, 1952 and recorded 29th day of February, 1952 in Book 253, Page 222 Deed Records of Lake County, State of Oregon, and which interest or lien covers the following described real property situated in the County of Klamath, State of Oregon, to-wit:

WHEREAS, Gilchrist Timber Company hereinafter called the "GRANTOR", has conveyed to the United States of America, hereinafter called the "GRANTEE", an easement for right-of-way purposes over and across said real property by virtue of instrument dated the 9 day of May, 1991.

WHEREAS, the Consentor, having a present right to use the road, reserves the right to continue to exercise the right to use the said road, or segment thereof, subject to compliance with traffic control regulations and rules as provided in 36 CFR 261.12 and the bearing of road maintenance costs proportionate to use as provided in 36 CFR 212.7(d).

NOW, THEREFORE, the creditor consents to the above mentioned conveyance from the grantor to the grantee and subordinates its interest in or lien upon the real property hereinbefore described to the rights of the grantee in and to said real property by virtue of the above mentioned instrument.
