Together with th debt thereby secured, is fully paid, satisfied and discharged.

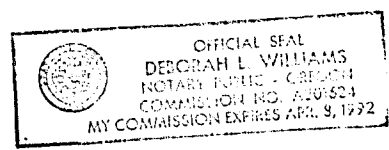
