KNOW ALL MEN BY THESE PRESENTS, That KATHLEEN M BENNETT

for the consideration hereinafter stated, does hereby remise, release and quitclaim unto

BENNETThereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of KLAMATH, State of Oregon, described as follows, to-wit:

The west 102 feet of Lot 1, Block 4, Altamont Acres.
 and a portion of Lot 2, Block 4, Altamont Acres, more particularly described as follows:

Beginning at Northwest corner of said Lot 2, thence east along North line of Lot 2, 102 feet; thence south parallel to west line of Lot 2, 60 feet; thence west 102 feet parallel to the North line of said Lot 2, to the west line of said Lot 2; thence North Along the west line of said line to the point of beginning.
