Based on the Affidavit of Delmar R. Young, Sharon King, Donald R. Young, Cheryl Young and Carla Draper, as Claiming Successors of Small Estate, the Court makes the following FINDINGS and ORDER:

FINDINGS:

The Court finds:

1. Delmar R. Young, Sharon King, Donald R. Young, Cheryl Young, and Carla Draper (Claiming Successors) filed their Affidavit as Claiming Successors of Small Estate (Affidavit) on October 24, 1990, affecting The Property.

2. The Claiming Successors have given notice of their Affidavit as required by law.

3. More than 120 days have expired since the filing of the Affidavit.

4. No claims have been filed by any creditor within four months after the filing the Affidavit.

5. No personal representative has been appointed within four months after the filing of the Affidavit.

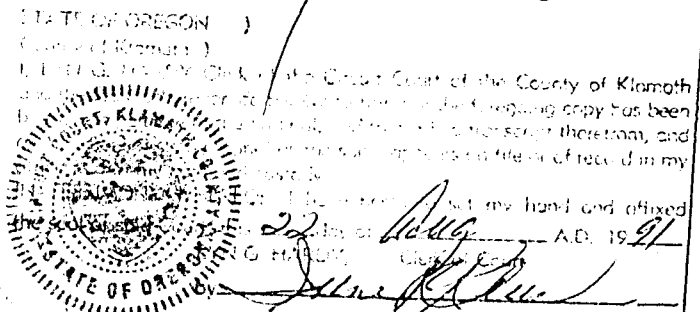
