RESOLUTION # 92-011

WHEREAS, on the 6th day of August, 1991 Leonard Benton and Elmina Benton, husband and wife, conveyed to Klamath County, Oregon certain property for County Road purposes, described as follows:

A parcel of land lying in Lots 9, 10 and 11 Altamont Ranch Tracts a tecorded subdivision Klamath County, Oregon; the said parcel being that portion of said Lots lying Southerly of what property described in that deed to the State of Oregon by and through its State Highway Commission, recorded in Book M65 Page 1754 of Klamath County Deed Records, Easterly of the property described in that deed to Klamath County recorded in Book M88 Page 4926 of Klamath County Deed Records; Northerly of a line parallel with and 120.7 feet Southerly of a line parallel with and 50 feet Easterly of the Westerly line of said Lots. The parcel of land to which this description applies contains 20,802 square feet, more or less.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session deemed it to be in the best interests of said County to accept the herein described property for County Road purposes;
