The SE1/4 NW1/4 NW1/4 of Section 29, Township 35 South, Range 11 East of the Willamette Meridian

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 250.00

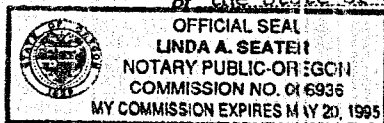
