In Witness Whereof the said vendor has executed this memorandum September 18, 1991.

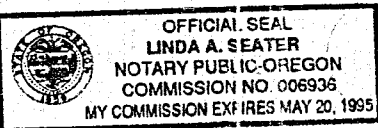
