The defaults of the Purchaser under the terms of the contract were not cured with the time period provided in ORS 93.915 and the contract has been forfeited.

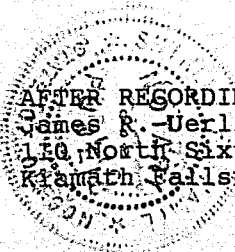

## 1. DESCRIPTION OF CONTRACT:

(A) PURCHASER: WILLIAM M. JACKSON

(B) SELLER: THE BANK OF CALIFORNIA, N.A., as Trustee

(C) CONTRACT RECORDED: 12-3-82, Vol. M82, Page 16974, Deed of records of Klamath County, dated 7-30-81

(D) AMOUNT AND TERMS OF CONTRACT: \$6600. \$900 down, balance of \$9814.80 at \$81.79 per month starting 10-15-81 until paid including 12% interest per annum.

(E) PROPERTY COVERED BY CONTRACT: Lot(s) 10 in Block 23, Mt. Scott Meadow, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

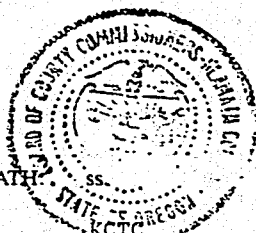

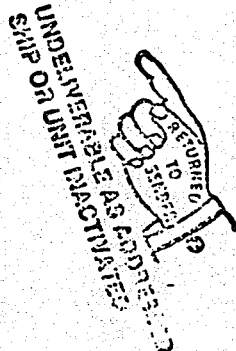
