

PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE, Made this 7 day of September, 1991, by and between Cheryl A. Blair and Jeff P. Coulson, the duly appointed, qualified and acting Co-Personal Representatives of the estate of Janine Lucette Coulson, deceased, hereinafter called the first party, and the Janine Coulson Bare Land Trust Agreement, acting by and through Cheryl A. TO HAVE AND TO HOLD the same unto the said second party, and second party's heirs, successors-in-interest and assigns forever.

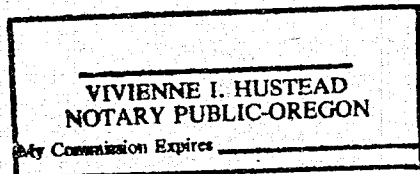
