**KNOW ALL MEN BY THESE PRESENTS, That** BENNY R. STARR AND JOAN A. STARR, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by WILLIAM N. WHITLATCH AND JULIE M. WHITLATCH, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A PORTION OF PARCEL 1 OF MINOR LAND PARTITION 80-49 Situated in the NE 1/4 NW 1/4, Section 9, T.39S., R.10E., W.M., Klamath County, Oregon.

Beginning at a 1/2 inch rebar with a plastic cap stamped 362 located on the northeast corner of said Parcel 1; thence S.00°07'00"W., along the easterly line of said Parcel 1, 11.42 feet to a 5/8 inch rebar with a plastic cap stamped LS2250; thence N.49°15'00"W., 60.30 feet to a point on the northerly line of said Parcel 1; thence S.58°33'38"E., along said northerly line 53.57 feet to the point of beginning.
