WHEREAS, Clifton H. & Patsy H. McMillan III made and entered into an agreement with Klamath County on February, 15, 1989, for the purchase of R-3809-033BB-07300 being described as: Supplemental Plat Railroad Addition, Lots 2A & 2B, Block 5, for the sum of \$800.00 with the sum of \$200.00 being paid as the first payment due on the Contract; and

WHEREAS, on June 17, 1991, the Property Control Assistant mailed a certified letter to Clifton H. & Patsy H. McMillan III in which the card was sent back to the office on July 5, 1991, requesting that the taxes be paid current on the property along with what was owed as per the Contract within ten days of the date of that letter; and

WHEREAS, no payment has been made and the Contract is now in DEFAULT; and

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Contract between Klamath County and Clifton H. & Patsy H. McMillan III dated February 15, 1989, is hereby declared null and void. A certified copy of this Order shall be mailed to Clifton H. & Patsy H. McMillan III at there last known address.

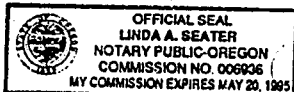
