KNOW ALL MEN BY THESE PRESENTS, That Klamath County, A Public Corporation of the State of Oregon, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Joseph J. McKee & Florence McKee, husband and wife, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The W1/2 SE1/4 SE1/4 of Section 27; Township 35 South, Range 12 East of the Willamette Meridian

SUBJECT TO: Contracts and/or lien for irrigation and/or drainage, and reservations, easements, restrictions and rights of way of record and those apparent on the land; rights of the public in and to any portion of said premises lying with the limits of roads and highways; subject to all sub-surface rights, except water as set forth in deed recorded on June 19, 1958 in Deed Volume 300 page 201; an easement created by instrument, including the terms and provisions thereof, dated February 21, 1962, recorded May 14, 1962, in Book 337 Page 403, Deed Records, in favor of Pacific Power & Light Co., for transmission and distribution of electricity over this and other property; reservations of any and all roads, trails, telephone lines, etc., including the terms and provisions thereof, as disclosed by deed recorded February 3, 1970, in M70 Page 850 and M70 Page 854.

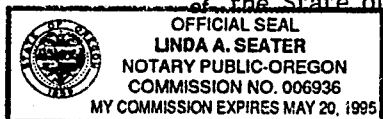
