WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That DAVID K. LEWIS, and CAROLYN LEWIS, husband and wife, hereinafter called the grantors, for the consideration hereinafter stated, to grantors paid by LAWRENCE WILSON and BESSIE WILSON, husband and wife, hereinafter called the grantees, do hereby grant, bargain, sell and convey unto the said grantees, as tenants by the entirety, their heirs and assigns, that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Commencing at a point marked by a 2-inch iron pipe, which is 30 feet north of the Southwest corner of Section 6, Township 39 South, Range 10 East of the Willamette Meridian; thence East parallel to the Southerly line of said Section a distance of 68 feet; thence North at right angles to the southerly line of said Section and parallel to the westerly line of said Section a distance of 207 feet; thence West and parallel to said southerly line of said Section a distance of 68 feet to the westerly line of said Section 6; thence South a distance of 207 feet to the point of beginning, and being situated in and a portion of Lot 7 of Section 6, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon.

SUBJECT TO: Liens and assessments of Klamath Project and Enterprise Irrigation District and regulations, contracts, easements, water and irrigation rights in connection therewith.

Any unpaid charges or assessments of Enterprise Irrigation District.

Acreage and use limitations under provisions of United States Statutes and regulations issued thereunder.

Reservations and restrictions contained in deed from Klamath Western Company to the First National Bank of Portland, Executor of the Estate of J. M. Baker, deceased, dated April 10, 1943, recorded August 20, 1943 in Deed Volume 158, Page 5, Records of Klamath County, Oregon, as follows: "Grantor reserves the right to itself, and to its successors in interest to lay and maintain underground pipes across said premises to supply domestic water to owners of adjacent land. This conveyance shall be subject to existing rights of the Enterprise Irrigation District to maintain and repair its ditches, laterals, headgates and other works on or adjacent to said premises, and to the further right of the grantor to run or permit to be run, laterals along the toe of said ditches or laterals to properly irrigate any lands in Lot 7 of Section 6, of Township 39 South, Range 10 East of the Willamette Meridian."

TO HAVE AND TO HOLD the same unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

And said grantors hereby covenant to and with said grantees, their heirs and assigns that grantors are lawfully seized in fee simple
