NOTICE OF SALE

Reference is made to that certain Trust Deed made by JOSE YARDEN, MANALO, A Single Man, as grantor, to ASPEN TITLE & ESCROW, INC., A California Corporation, as trustee, in favor of F.N. REALTY SERVICES, INC., A California Corporation, Trustee, as beneficiary, dated July 23, 1988, recorded December 20, 1988, in the mortgage records of Klamath County, Oregon, in Book No. M-88 at page 21617, covering the following described real property situated in said county and state, to-wit:

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Oregon Revised Statutes 86.735(3); the default for which the foreclosure is made is grantor's failure to pay when due the following sums:

Monthly installments of principal and interest due for the months of June, July, August, September, October, November, and December of 1990, and January, February, March, April, May and June of 1991 in the amounts of \$130.24 each; and subsequent installments of like amounts; subsequent amounts for assessments due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit:

\$8,974.02 plus interest and late charges, thereon from May 20, 1990 at the rate of NINE AND ONE-HALF (9.5%) PER CENT PER ANNUM until paid and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Trust Deed.
