KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated October 23, 19 87, executed and delivered by HOWARD E. MCGEE, JR. and KELLY B. MCGEE, husband & wife as grantor and recorded on October 23, 19 87, in the Mortgage Records of Klamath County, Oregon, in book M87 at page 19334, conveying real property situated in said county described as follows:

A parcel of land located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 34, Township 38 South, Range 11 $\frac{1}{2}$ East of the Willamette Meridian, in the County of Klamath, State of Oregon, being more particularly described as follows:

Beginning at a point from which the North quarter corner of Section 34, Township 38 South, Range 11 $\frac{1}{2}$ East of the Willamette Meridian, bears South 89° 15' 20" East 60.00 feet and North 00° 12' 45" East 41.00 feet distant; thence South 00° 12' 45" West 245.71 feet; thence North 89° 55' 07" West 180.00 feet; thence North 00° 12' 45" East 247.80 feet; thence South 89° 15' 20" East 180.01 feet to the point of beginning.

TOGETHER WITH A NON-EXCLUSIVE PRIVATE ROAD EASEMENT DESCRIBED AS FOLLOWS:

TOGETHER WITH A strip of land 60.00 feet wide located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 34, Township 38 South, Range 11 $\frac{1}{2}$ East of the Willamette Meridian, in the County of Klamath, State of Oregon, being more particularly described as follows:

Beginning at a point on the North-South centerline of Section 34, Township 38 South, Range 11 $\frac{1}{2}$ East of the Willamette Meridian, from which point the North quarter corner of said Section 34 bears North 00° 12' 45" East 41.00 feet distant; thence South 00° 12' 45" West along said North-South centerline 209.75 feet to a point on the Northerly right of way line of State Highway 140; thence following said right of way line along the arc of a 2824.79 foot radius curve to the right 96.35 feet, the long chord of which bears South 38° 43' 23" West 96.34 feet; thence North 00° 12' 45" East 285.71 feet; thence South 89° 15' 20" East 60.00 feet to the point of beginning.


