WHEREAS, on September 12, 1991, the Property Control Assistant mailed a certified letter to Gerald M. WHEREAS, on October 30, 1991, being the 21 days given Gerald M. Craden has failed to bring the Contract current and is now DEFAULT; and

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Contract between Klamath County and Gerald M. Craden dated May 28, 1990, is hereby declared null and void. A certified copy of this Order shall be mailed to Gerald M. Craden at his last known address.
