SUBJECT to, conditions and recitals, including the terms and provisions thereof, as set out in that certain deed recorded October 14, 1965, in Volume M65, Page 2753.

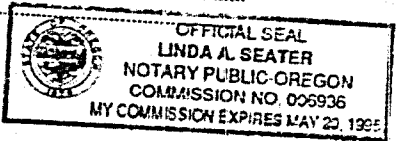
