A parcel of land lying in the East half of the Southeast quarter of the Southeast quarter (E½ SE¼ SE¼) of Section 4, Township 34 South, Range 7 East, W. M., Klamath County, Oregon. The said parcel being described as follows: a strip of land 40 feet in width, 20 feet on each side of the center line described as follows:

Beginning at a point on the Easterly right of way line of the relocated The Dalles-California Highway, said point being 70 feet distant Easterly from (when measured at right angles to) the relocated center line of the said highway at Engineer Station 2844+00 said point also being 193 feet North and 552 feet West of the Southeast corner of Section 4; thence South 80° 08' East a distance of 164.5 feet; thence North 46° 5' East a distance of 521.6 feet to a point on the East line of Section 4.

The parcel of land to which this description applies contains 0.63 acre.

WHEREAS, the State of Oregon, by and through its Parks and Recreation Department, hereinafter called the "GRANTOR," has conveyed to the United States of America, hereinafter called the "GRANTEE," an easement for right-of-way purpose(s) over and across said real property by virtue of the instrument dated May 30, 1991, and recorded June 25, 1991, in Volume M91, page 12130, Klamath County, Records, State of Oregon.

WHEREAS, the CONSENTER, having a present right to use the road, reserves the right to continue to exercise the right to use said road, or segment thereof, subject to CONSENTER'S compliance with traffic control regulations and rules as provided in 36 CFR CH II (7-1-90 Edition) S.261.12, and CONSENTER'S bearing of road maintenance costs proportionate to use as provided in 36CFR, CH II (7-1-90 Edition) S.261.12 in 36 CFR, CH II (7-1-90 Edition) S212.7(d).

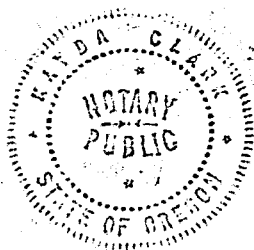
