## RIGHT-OF-WAY EASEMENT

The Southwest Quarter of the Northwest Quarter (SW1/4NW1/4) of Section 27, Township 40 South, Range 12 East, Willamette Meridian, as shown on Exhibit "A" attached hereto and by this reference made a part hereof.

As more particularly described on attached Exhibit(\*) "B" by this reference made a part hereof.

The within grant shall include: The right to install and maintain guys and anchors outside said right-of-way; the right to clear said right-of-way and keep the same clear of brush, trees, timber and structures; the present and future right to clear and cut away all trees outside of said present and future right endanger said transmission line; the right to conright-of-way which might endanger said transmission line; the right to construct, reconstruct, operate, maintain, replace, enlarge, repair and remove struct, reconstruct, and the right of ingress and egress over adjacent lands of Grantor for all said purposes.

Grantee shall pay to Grantor reasonable compensation for any damage caused by Grantee to any property or crops on the above-described real property arising out of the use thereof by Grantee.

At no time shall any flammable material or any building of any kind be placed or erected within the boundaries of said right-of-way, nor shall any equipment or material of any kind that exceeds 20 feet in height be placed or used thereon by Grantor or by Grantor's successors or assigns.



## DESCRIPTION

## Robert N. & Pauline M. Latzy

That portion of a right-of-way 175 feet wide over and across the Southwest Quarter of the Northwest Quarter (SW1/4NW1/4) of Section 27 in Township 40 South, Range 12 East of the Willamette Meridian in Klamath County, Oregon.
