## EASEMENT SUPPLEMENT

WHEREAS, by Easement Agreement, dated the 12th day of September, 1960, herein referred to as "Original Easement," as recorded in Deed Records of Klamath County, Oregon in Volume 324, Page 295, under Auditor's No. 54391, CROWN ZELLERBACH CORPORATION, Nevada corporation, granted to PACIFIC GAS а TRANSMISSION COMPANY, a California corporation, herein referred to as "PACIFIC," an easement and right of way for a pipe line or lines for the purpose of transporting gas and other liquid hydrocarbons; and

WHEREAS, WEYERHAEUSER COMPANY, a Washington corporation, herein referred to as "WEYERHAEUSER," is successor in interest to Crown Zellerbach Corporation; and

WHEREAS, PACIFIC has requested, and WEYERHAEUSER has agreed, that said Original Easement be supplemented to grant PACIFIC an easement and right of way for the same purpose over and across the NE<sup>1</sup>/<sub>4</sub>NW<sup>1</sup>/<sub>4</sub> of Section 31, Township 27 South, Range 8 East, W.M., said county and state.

NOW THEREFORE, WEYERHAEUSER and PACIFIC hereby agree that Exhibit "A" of said Original Easement is hereby supplemented to include the NE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 31, Township 27 South, Range 8 East, W.M., Klamath County, Oregon.

It is further agreed that said easement and right of way shall be limited to a strip of land one hundred feet (100') in width, lying between lines parallel to and situate thirty feet (30') to the right and seventy feet (70') to the left (going in a general southerly direction through the State of Oregon) measured at right angles from the center line (or tangent thereof if a curve) of PACIFIC's existing pipe, such parallel lines being extended to the boundary lines of the said lands so as to enclose the right of way and easement.

PACIFIC shall further define the location of said strip by recording a "Notice of Location" referring to this instrument and setting forth a legal description of the location of said existing pipe or said strip, which description may be set forth by map attached to said Notice. A copy of said Notice shall be delivered to WEYERHAEUSER.
