## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Arthur Adolphe LeCours and Harriett Ann LeCours, Husband and Wife, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Arthur Adolphe LeCours and Harriett Ann LeCours, or successor, as Trustee under Living Trust dated 1/7/92, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 4 in Block 15 of First Addition to the City of Klamath Falls, Oregon according to the official plat thereof on file in the records of Klamath County, Oregon.

"This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations. To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except those of record and those apparent upon the land, if any, as 'offthe date of this deed, and that grantor will warrant and forever defend the said premises and every party of parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
