GRANT OF ROADWAY EASEMENT

This grant of easement is by and between GENE D. SPILLANE AND VIRGINIA G. SPILLANE, herinafter referred to as "the owners of parcel 1"; and MARGURETTE L. ALBERT AND WILMA F. HARPER, herinafter referred to as the "owners of parcel 2."

Parcel 1 is a portion of the East 1/2 of the Southeast 1/4 and the Southwest 1/4 of the Southeast 1/4 of Section 3 Township 40 South, Range 13 East of the Willamette Meridian in the County of Klamath, State of Oregon. Tax Lot #4013-31000, Now Known As #4013-300-1000

Parcel 2 is all that portion of the Southwest 1/4 lying Northerly and Easterly of the U.S.B.R Lost River Channel Improvement, Northwest 1/4 Southeast 1/4 of Section 3, Township 40 South, Range 13 East of the Willamette Meridian, in the County of Klamath, State of Oregon.

In consideration of the sum of FIVE HUNDRED DOLLARS (\$500), receipt of which is hereby acknowledged, the owners of Parcel 1, for themselves, their heirs and assigns, hereby grant to the owners of Parcel 2, their heirs and assigns, a roadway easement over and across the Northern boundary of parcel 1, 40 feet in width, and runnning parallel to the existing drainage ditch also running along said Northern boundary. The roadway easement shall be for the purpose of giving the owners of parcel 2 ingress and egress to parcel 2 from Gale Road.

The owners of Parcel 2 may, at their option and sole expense, construct and maintain an all-weather road across the easement created herein.

The easement granted herein shall run with the land as to all properties burdened and benefitted by such easement, including any division or partition of said property. The rights, convenants and obligations contained in this agreement shall bind, burden and benefit each party's successors, assigns, lessees, mortgagees, or beneficiaries under a deed of trust. Notwithstanding the foregoing, this easement shall be extinguished in the event that parcel 2 comes into the ownersip of RichardBarrett and Willie Mendenhall.
