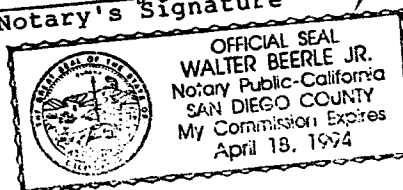

LAST WILL AND TESTAMENT
OF
VIRGINIA REKRUT

I, VIRGINIA REKRUT, a resident of this city of San Diego, County of San Diego, State of California, being of sound and disposing mind and memory and not acting under duress, menace, fraud or the undue influence of any person whomsoever, do hereby make, publish and declare this to be my Last Will and Testament and I hereby revoke any and all previous Wills or Codicils executed by me.

I declare that I am single, and have never been married.

FIRST: I hereby donate all of my usable organs for transplant purposes. I will sign necessary instructions with my doctors for immediate removal. My remains are then to be cremated and scattered at sea.

SECOND: I give my brother, STANLEY REKRUT, and my sister NATALIE SULLIVAN both the sum of \$5,000 each. In event of the death of either one the share of the deceased shall go to the survivor of them. In event neither survive me, this specific bequest shall lapse and become part of the residue of my estate.

THIRD: I give \$5,000 to CRUCE CICIO, the niece of VINCENT TOMBRELLO. In event she does not survive me her share shall lapse and become part of the residue of my estate.

FOURTH: I give \$5,000 to VINCENT TOMBURELLO, JR. who is the son of VINCENT TOMBURELLO who is one of the residuary legatees

of my Will. In event that VINCENT TOMBURELLO, JR. does not survive me, his share shall lapse and become part of the residue of my estate.

SIXTH: The rest, residue and remainder of my estate, wherever situate, real or personal, I give, devise and bequeath to VINCENT and ANNIE TOMBURELLO, or the survivor of them. VINCENT is the nephew of VINCENT J. TOMBURELLO, my deceased benefactor.

SEVENTH: I direct that in event anyone contests this Will or participates or cooperates in a contest of this Will, then I leave the sum of One (\$1.00) Dollar to those who initiate, cooperate or participate directly or indirectly in a contest of this Will.

EIGHTH: I nominate VINCENT TOMBURELLO as executor of my Will and direct that my executor shall serve without bond and that he shall have power of sale, public or private, with or without notice, subject only to confirmation by Court.
