Hathaway , hereinafter called the "Granter". and Maertie Hathaway, his wife do hereby grant and convey to the United States of America, acting by and through the Forest Service, U.S.D.A., and assigns, hereinefter called the "Government", an easement and right-of-way, including, but not limited to. the right, privilege and authority to locate, construct, re-locate, maintain, patrol and repair a roadway and electric and telephone transmission lines over, upon, along and acress the fellowing-described real property situated in the County of Klamath. State of Oregon, to-wit:

> A strip of land 66 feet in width traversing the following described real property:

The NET of the NW1 of Section 22; the W2 of the NE1 of Section 22; the NW1 of the SB1 of Section 22; the Sa of the SB1 of Section 22; (the SW1 of the HW1 of Section 26; the NW1 of the SW1 of Section 26; all in T. 388., R. 15E., W. M.

The said strip being 33 feet in width on each side of a center line more particularly described as follows:
