KNOW ALL MEN BY THESE PRESENTS, That MARGARET A. PASCHAL, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto MARGARET A. PASCHAL, JR., not as tenants in common but with the rights of survivorship hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:
