A portion of the SE\nW\; of Section 1, Township 40 South, Range 7 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point 200 feet West of the center of Section 1, Township 40 South, Range 7 East of the Willamette Meridian; thence North 1,030 feet to the Southerly right of way of the Klamath Falls-Ashland Highway; thence S. 57° W. 238.4 feet along said right of way; thence South 900 feet; thence East 200 feet to the point of beginning.
