Upon any default by grantor hereunder, beneficiary may at any time without notice, either in person, by agent or by a receiver to be appointed by a court, and without regard to the adequacy of any security to the indebtedness hereby secured, enter upon and take possession of said property or any part thereof, in its own name sue or otherwise collect the rents issues and prolits, including those past use and unpaid, and apply the same, less costs and expenses of operation and collection, including freasonable attorney's lees upon any indebtedness secured hereby, and in such order as beneficiary may determine.
