SHERIFF'S DEED

WHEREAS, the Circuit Court for the State of Oregon for Klamath County, did on the 24th day of December, 1990, make and enter a decree of foreclosure in favor of the State of Oregon, represented and acting by the Director of Veterans' Affairs, against Eddie V. Young; Sharon L. Young, aka Sharon L. Jones; County of Klamath; United States of America, Internal Revenue Service; Kevin Davis; and Deborah Davis, foreclosing them of all their right, title, estate, lien or interest in or to the premises hereinafter described or any portion thereof, on which decree a writ of execution in foreclosure was issued, dated the 11th day of January, 1991, directed to the Sheriff of said county to execute; and by virtue of said execution in foreclosure the lands hereinafter described were struck off and sold to the State of Oregon, represented and acting by the Director of Veterans' Affairs, it being the highest and best bidder therefore, on the 26th day of February, 1991, and the time and place thereof having been duly advertised according to law. 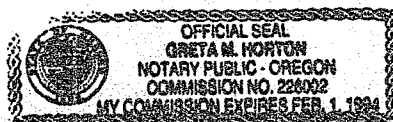
