NOTICE OF CLAIM
OF ATTORNEY'S LIEN
(Real Property)

This Lien arises out of legal services provided to Respondent, Wayne William Cunningham in the above captioned suit in the Circuit Court of the State of Oregon for the County of Klamath.

The reasonable and agreed value of Claimant's services performed in said suit was \$1,000.00. There is a remaining unpaid balance of \$800.00. 
