RESOLUTION # 92-050

WHEREAS, on the 3rd day of April, 1992 Paul E. Sticklen and Mary L. Sticklen, husband and wife, Grantors, conveyed to Klamath County, Oregon certain property for County Road purposes, described as follows:

A parcel of land situated in the NW $\frac{1}{4}$  of Section 26, T.38S., R.11 $\frac{1}{2}$ E., W.M., Klamath County, Oregon for road purposes, being a portion of that property described in Deed Volume M82, Page 3228, Microfilm Records of Klamath County recorded in the Klamath County Clerk's office, and being more particularly described as follows:

Commencing at the corner common to Sections 22, 23, 26 & 27, T.38S., R.11 $\frac{1}{2}$ E., W.M., Klamath County, Oregon; thence S.89° 46'43" E., 23.72 feet to a  $\frac{1}{2}$ " iron pin on the easterly right of way line of Hildebrand Road; thence S.00°21'30"W. along said right of way line, 1283.58 feet to a  $\frac{5}{8}$ " iron pin curve point which is the true point of beginning; thence following said right of way 88.22 feet along the arc of a 300.00 foot radius curve to the left (the long chord of which bears S.08°04'00"E., 87.91 feet) to a  $\frac{1}{2}$ " iron pin; thence S.16°29'30" E. along said right of way line 25.69 feet to the intersection with the westerly right of way line of Highway #140; thence N.32°44'54" E. along said right of way line, 83.31 feet to a  $\frac{5}{8}$ " iron pin; thence N.57°15'06" W. 76.92 feet to the true point of beginning, and

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session deemed it to be in the best interests of said County to accept the herein described property for County Road purposes;

NOW THEREFORE IT IS HEREBY RESOLVED that the property conveyed to Klamath County, Oregon by Paul E. and Mary L. Sticklen on the 3rd day of April, 1992 shall be accepted as County Road right of way for Hildebrand Road.
