AMENDMENT TO EASEMENT

THIS AGREEMENT, made and entered into this Q1992, by and between JAMES R. DeBAUN, TRUSTEE, AND/OR ANY SUCCESSOR TRUSTEE, UNDER WRITTEN DECLARATION OF TRUST DATED SEPTEMBER 2, 1972 hereinafter referred to as Grantor, and JAMES R. Said easement to be a parcel of land with a radius of 25 feet about said spring, and an access strip of land 40 feet in width for non-exclusive private roadway, agriculture, mining and forestry use meandering between said spring and a strip of land 40 feet in width for non-exclusive private roadway, agriculture, mining and forestry use meandering to and from the Pacific Northwest Bell Telephone Company road in the SE 1/4 Section 25 through the S 1/2 of Section 25, Township 36 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, and through the E 1/2 of the NW 1/4 and NE 1/4 of Section 36, Township 36 South, Range 12 East of the Willamette Meridian, Klamath

Said Grantor and Grantee desire to amend said easement to extinguish the access easement across the SE 1/4 of Section 25 and the NE 1/4 and the E 1/2 NW 1/4 of Section 36 of said Township 36 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, to the spring, however, retain the right to draw and pump water from said spring the S 1/2 of Section 25, Township 36 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon.
