

The undersigned states:

Creditor is entitled to a writ of execution pursuant to Stipulated Judgment and Decree of Foreclosure entered on March 26, 1992, in the Circuit Court of Klamath County, State of Oregon, under case no. 9103955CV.

B. February 10, 1983, the recording date of the mortgage recorded in Vol. M83, Page 2188 of the official records of Klamath County, Oregon, and all of their interest thereafter, to satisfy the sum of \$37,067.90 in principal (\$37,977.90 less \$910.00 in stock retired pursuant to the decree), plus \$1,969.60 in accrued interest to March 26, 1992, and

C. plus \$3,025.00 for Plaintiff's reasonable attorney fees, plus costs and disbursements in the sum of \$168.00, plus interest upon the total of said sums above (\$317,859.64) at the rate of 13.25% per annum from the date of judgment until paid, and the costs of the writ, making due return within 60 days after the Sheriff's receipt of the writ.
