The Chief Schonchin Cemetary Association, Grantor, releases and quitclaims to the Klamath Tribes, a federally recognized tribe, Grantee, all rights, title and interest in the following described real property situated in Klamath County, Oregon:

Township 36, Range 11, Section 25, Tract Portion SE4NE4, E.W.M., Klamath County, State of Oregon, an area otherwise know as the Schonchin Cemetary, and containing approximately 5 acres.

This conveyance is subject to all valid existing rights, including liens, easements and outstanding taxes. This conveyance shall have the effect of giving perpetual use of the property for purposes of burial, subject to the laws of the State of Oregon and the Bylaws of the Chief Schonchin Cemetary Association and no subsequent sale or conveyance of the property shall be valid unless approved by a majority of the Trustees of the Association.

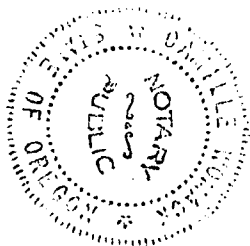
The true consideration for this conveyance is one dollar (\$1.00).
