BARNETT (S/S No. 544-72-8085) hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendor's right, title and interest in and to that certain contract for the sale of real estate dated NOVEMBER 3, 1980, between MICHAEL B. & MARGARET H.
