The West half of the Northwest quarter of Section 16 Township 39 South of Range 10 East of the Willamette Meridian, saving and excepting therefrom that portion of the Southwest quarter of the Northwest quarter lying Southerly of the O.C.&E. Railroad, and also saving and excepting therefrom that portion of the NW1/4 lying Northerly of the Klamath Falls-Lakeview Highway.

The SE1/4 NW1/4 and all that portion of the NE1/4 NW1/4 lying Southerly of the Klamath Falls-Lakeview highway and all that portion of the NE1/4 SW1/4 lying Northerly of the O.C.&E. Railroad, all in Section 16 Township 39 South of Range 10 East of the Willamette Meridian.
