MODIFICATION AND EXTENSION OF TIMBER DEED

WHEREAS, CROWN PACIFIC, LTD., an Oregon corporation, by a Warranty Timber Deed, dated April 5, 1988, recorded April 8, 1988 in Volume M88, page 5320, Deed Records of Klamath County, Oregon (the "Timber Deed") conveyed to SCOTT TIMBER CO., an Oregon corporation, the right to cut and remove certain timber, all as described and set forth in said Timber Deed; and

partnership, Grantor, conveys and warrants to SCOTT TIMBER CO.,

an Oregon corporation, Grantee, all of the timber, trees and logs

of every kind and species, and all natural increases thereof,

with a DBH of eleven inches (11") or more at time of cutting now

or hereafter growing, standing, lying or being on the premises

located in Klamath County, Oregon, described in Exhibit A

attached hereto and incorporated herein by this reference.

TO HAVE AND TO HOLD said property and easements, rights and privileges appurtenant thereto unto the Grantee, its

successors and assigns, for the term commencing with the date hereof and ending December 31, 1997.

And the Grantor does covenant to and with the Grantee, its successors and assigns, that the forest products hereby conveyed are free and clear of liens and encumbrances, except as listed in the Timber Deed, and that the Grantor will, and its successors and assigns shall, forever defend the same against the lawful claims and demands of any and all persons whomsoever.

All of the terms and provisions of the said Timber

Deed, except the termination date of the right to cut and remove

timber, are incorporated herein and made a part hereof. All of

the rights granted to Grantee hereunder are subject to the terms

and provisions of an Agreement dated February 12, 1992 between

Grantor and Grantee.

The true consideration for this conveyance consists of property and value other than cash.
