

TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT dated this 12th day of May, 1992, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture.

WHEREAS, Gilchrist Timber Company granted to the United States of America a temporary easement for Rock Creek Road No. 2415, dated March 13, 1972, and recorded on March 16, 1972, in Book M72, at page 2843, County of Klamath, State of Oregon, over and across the following described premises:

"This grants shall continue as long as needed for the above purposes, and shall expire upon completion of the above work, or on January 1, 1978, whichever occurs first."



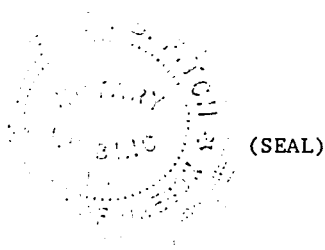
