> Said property located in The Northeast Quarter (NE $\frac{1}{4}$ ) of The Northeast Quarter (NE $\frac{1}{4}$ ) of Section 19, and The Northwest Quarter (NW $\frac{1}{4}$ ), of The Northwest Quarter (NE $\frac{1}{4}$ ), Section 20, both being situated in Township 38 South, Range 9 East, Willamette Meridian

The location and course of said easement and right-of-way are approximately as shown on the sketch attached as Exhibit(s) "A" \_\_\_\_ and by this reference made a part hereof.

Together with the right of ingress and egress over the adjacent lands of the Grantor in order to install, maintain, repair, replace, rebuild, operate and patrol the underground electric power lines and appurtenances, and to exercise all other rights herein granted.
