IT IS FURTHER ORDERED:





IDLEREST SUBDIVISION VACATION (OREM)

Vacation of Lots 19 through 28 of Block 1 and Lots 19 and 20 of Block 4, and a portion of Willow Way in the Plat of Idlerest in Section 4, T.34S., R.7E., W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at the Northeast Corner of Lot 18, Block 4 of Idlerest; thence Southwesterly along the Westerly right-of-way of Willow Way to the Northeast Corner of Lot 19, Block 4; thence N.89°40'W., 73.4 feet along the North boundary of Lot 19 to the Northwest Corner of Lot 19; thence S.0°20'W., 50.0 feet along the West boundary of Lots 19 & 20 to the Southwest Corner of Lot 20; thence S.89°40'E., 58.0 feet along the South boundary of Lot 20 to the Southeast Corner of Lot 20; thence Southwesterly 52.3 feet along the Westerly right-of-way of Willow Way to the Southeast Corner of Lot 8; thence S89°40'E. on the projection of the South boundary of Lot 8 to the easterly right-of-way of Willow Way; thence Southwesterly along the Easterly right-of-way of Willow Way to the Southwest Corner of Lot 19, Block 1; thence S.89°40'E., 72.2. feet along the South boundary of Lot 19 to the Southeast Corner of Lot 19; thence Northeasterly along the Easterly boundary of Lots 19 through 28, Block 1 to the Northeast Corner of Lot 28; thence N.89°40'W. along the South right-of-way of Clearwater Avenue to the Northeast Corner of Lot 18, Block 4, the point of beginning.

Bearings and distances in this description are based on the Plat of Idlerest.
