

DEED CREATING ESTATE BY THE ENTIRETY

KNOW ALL MEN BY THESE PRESENTS, that BOBBY JACK GARRETT, SR. Grantor for the consideration hereinafter stated, has bargained and sold and by these presents does grant, bargain, sell and convey unto DORIS A. GARRETT, Grantee an undivided one-half interest in and to the following described real property situated in the County of KLAMATH, State of Oregon, to-wit:

Parcel No. 1 Portion of Lot 10, Section 6, Township 35, Range 7, Tax Assessor's Account No. 226721, being approximately .76 acres.

Parcel No. 2 Portion of Lot 15, Section 6, Township 35, Range 7, Tax Assessor's Account No. 228060, being approximately .7 acres.

Said grantor hereby covenants to and with grantee and grantees heirs, successors and assigns that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances save and except those of record in the deed records of Klamath County, Oregon.

Together with all and singular tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining; TO HAVE AND TO HOLD said undivided one-half of said real property unto the said grantee forever. The above named grantor retains a like one-half interest in and to said real property and it is the intent and purpose of this instrument to create and there hereby is created an estate by the entirety between the grantor and the grantee herein as to the said real property. 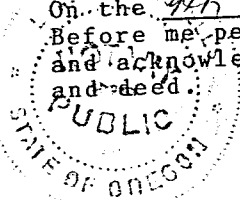
