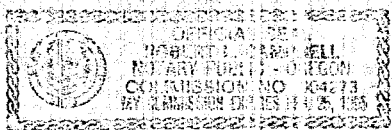
"CONSENT AGREEMENT"

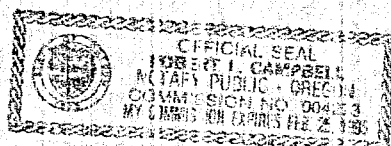

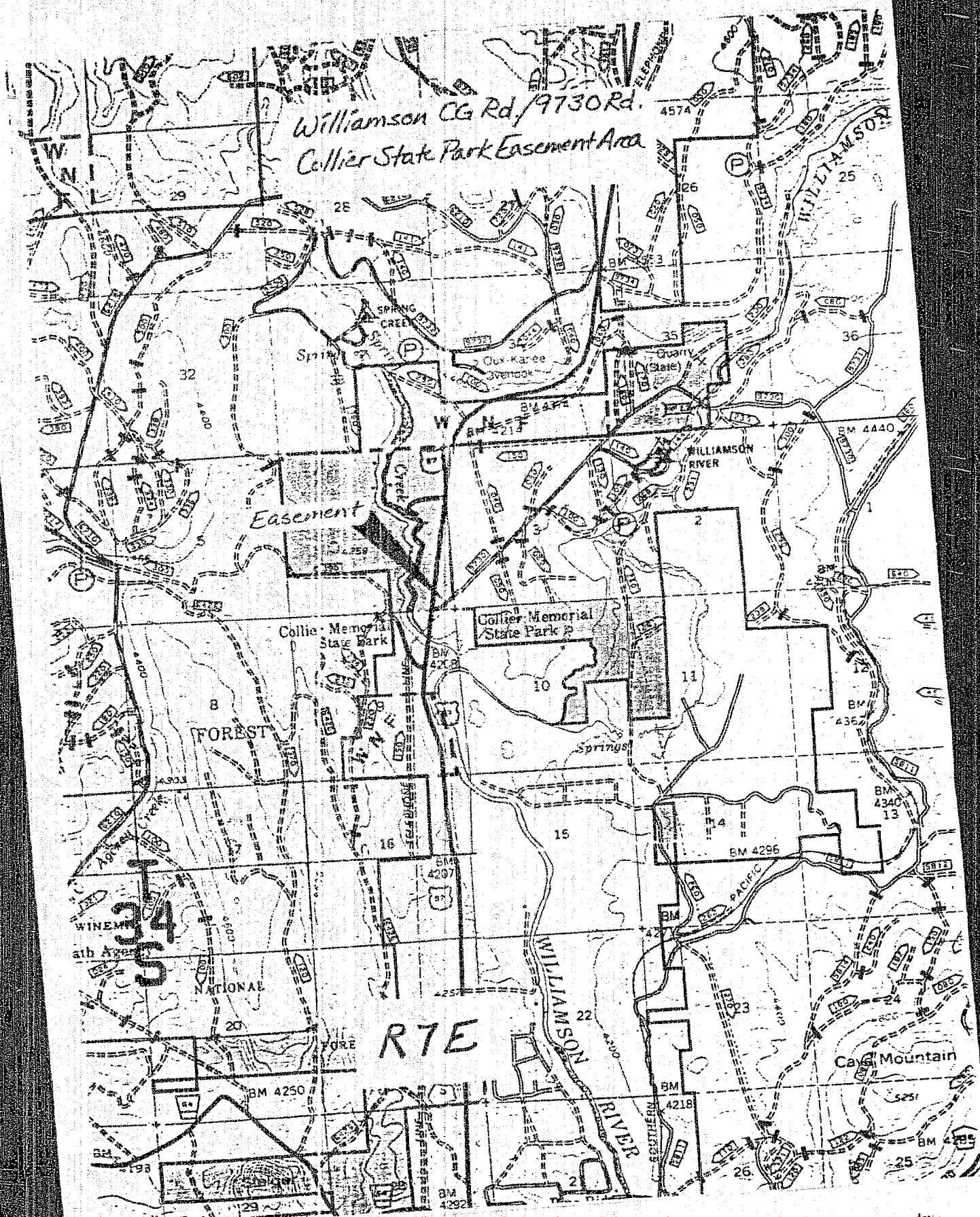
