The N1/2 of the North 198 feet and the S1/2 of the North 198 feet of TRACT 22 of
 ALTAMONT SMALL FARMS, according to the official plat thereof on file in the office
 of the County Clerk of Klamath County, Oregon.

 grantor will warrant and forever defend the premises and every part and parcel thereof against the lawful claims
 and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$49,500.00

 changes shall be made so that this deed shall apply equally to corporations and to individuals.


