 the certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining,  
 situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 35 of Block 24, Tract 1113, OREGON SHORES UNIT 2, according to the  
 official plat thereof on file in the office of the County Clerk of  
 Klamath County, Oregon.

 #AB7SC1418CR which is situate on the real property described herein.


