ORDER OF VACATION - #93-003

According to provisions of ORS 368.341(3) and ORS 368.351, a Petition containing the acknowledged signatures of the owners of 100% of the property abutting the public property described in Exhibit "A" proposed to be vacated and indicating said owners' approval of the proposed vacation was filed with the board on 18th day of June, 1992.

Thereafter, Earl Kessler, the County Engineer, filed with this Board a written report that contained the following:

1. A description of the ownership and uses of the property proposed to be vacated.

2. An assessment by the County Engineer whether the vacation would be in the public interest.

3. Other information required by the County commissioners. And after fully considering the report and other documentation presented

NOW AND THEREFORE;

This Board finds that the vacation of portion of said Waverly Way is in the public interest and finds that the Petition should be granted and that the real property be vacated.

NOW AND THEREFORE; IT IS HEREBY ORDERED:

That the Petition is granted and that the portion OF Waverly Way as described on Exhibit "A" is hereby vacated, as said vacation is in the public interest.

IT IS FURTHER ORDERED:

That the cost resulting from the approved vacation are determined to be the sum of \$ 46.00 and that the persons liable for payment of the costs are the Petitioners.

IDLEREST SUBDIVISION VACATION

Vacation of Lots 1 through 7 of Block 2 and a portion of Waverly Way in the Plat of Idlerest in Section 4, T.34s., R.7e., W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at the Northwest Corner of Lot 7, Block 2; thence in a straight line Southwesterly across Waverly Way to the most Northerly Northeast Corner of Lot 2, Block 3; thence S.32°31'W., 119.0 feet along the Westerly right-of-way of Waverly Way to the North Right-of-way of Clearwater Avenue; thence S.89°40'E. along the North right-of-way of Clearwater Avenue to the Southeast Corner of Lot 1, Block 2; thence Northerly along the Easterly boundary of Lots 1 through 7, Block 2 to the Northeast Corner of Lot 7; thence Southwesterly along the north Boundary of Lot 7 to the Northwest Corner of Lot 7, the point of beginning.

Bearings and distances in this description are based on the Plat of Idlerest.
